Standard Finishes

1. All internal shelving will be in 16mm white melamine with a nominal depth of 450mm
2. All side walls will be in 16mm white melamine finish with a nominal depth of 670mm
3. Glazing vinyl used will be in a clear "frost" colour
4. Aluminium materials may have minor finish variations regarded to be within industry standards

Conditions of Contract

1. Kolder Pty Ltd will supply the product/s shown on this contract in return for payment of the amount shown at the agreed time of payment (see 11 below)
2. The customer signing this contract has the authority to do so and accepts the terms of this contract
3. Kolder Pty Ltd will not accept responsibility for any structural damage which results from work performed by other people
4. Kolder Pty Ltd will not accept responsibility for any damage caused during removal of existing fitting or fixtures
5. Acceptance of this contract gives Kolder Pty Ltd the authority to commence cutting material for the product/s. The order cannot be cancelled once cutting has commenced.
6. Kolder Pty Ltd will wherever possible install the product/s on the agreed date.
Kolder Pty Ltd has the right to alter the agreed installation date when events beyond control make it necessary
7. Kolder Pty Ltd will remove any unused materials & offcuts on completion of installation. The removal of other material is the customer's responsibility unless other stated on the contract
8. Ownership of the product/s does not pass to the buyer until Kolder Pty Ltd has received full payment
9. Kolder Pty Ltd guarantees its built in robe products for 10 years when used normally.
Kolder Pty Ltd guarantees its shower screen & mirror products for 5 years when used normally.
The Kolder Pty Ltd guarantee does not cover accidental damage (Including glass breakage) or damaged through misuse.
10. The conditions in this contract do not negate any conditions of the 'Trade Practices Act'
11. The balance payable must be paid on installation date unless prior arrangements have been agreed by Kolder Pty Ltd
12. The customer understands & agrees that Kolder Pty Ltd may obtain information about the customer from a credit reporting agency to enable Kolder Pty Ltd to assess the customer's application for a trading account
